

## Vandal Resistant Hot-Line Panel Phones with Keypad

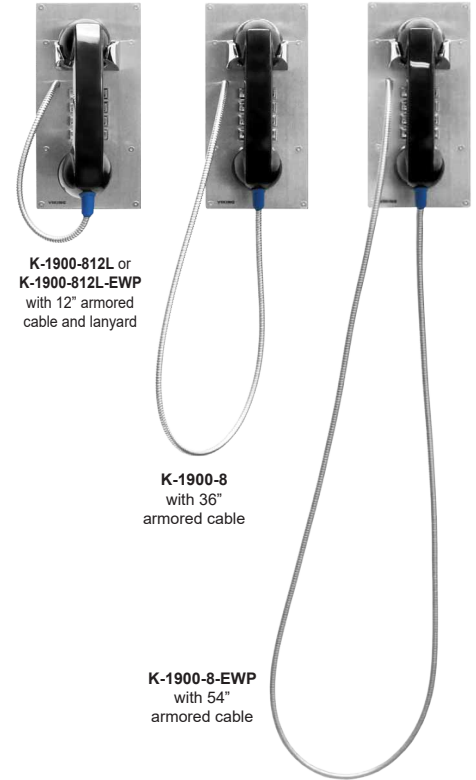
The **K-1900-8 Series** panel phone can either auto-dial a phone number each time the handset is lifted, be used as a multi-number auto-dialer, or be used as a standard (dumb) phone. The unit will touch tone or pulse dial and will not auto-dial on incoming calls.

The **K-1900-8 Series** housing consists of a heavy gauge stainless steel panel, metal touch tone keypad, armored cable, heavy duty handset, and all metal cradle. The **K-1900-8 Series** can be easily touch tone programmed at the shop or installation site. All programming is stored in non-volatile memory.

The **K-1900-812L** and **K-1900-812L-EWP** feature a 12" long armored cable with an internal stainless steel lanyard for additional cable strength.

The **K-1900-8-EWP** and **K-1900-812L-EWP** share all the features of the **K-1900-8** and **K-1900-812L** in addition to Enhanced Weather Protection (EWP) for outdoor installations where the unit is exposed to precipitation or condensation. EWP products are designed to meet IP66 standards and may feature foam rubber gaskets, sealed connections, gel-filled butt connectors, as well as potted circuit boards with internally sealed, field-adjustable trim pots and DIP switches for easy on-site programming. **Note:** If a ringer is required, use an external unit such as the Viking **SR-1 (DOD 477)**, or **LPR-1 (DOD 550)**.

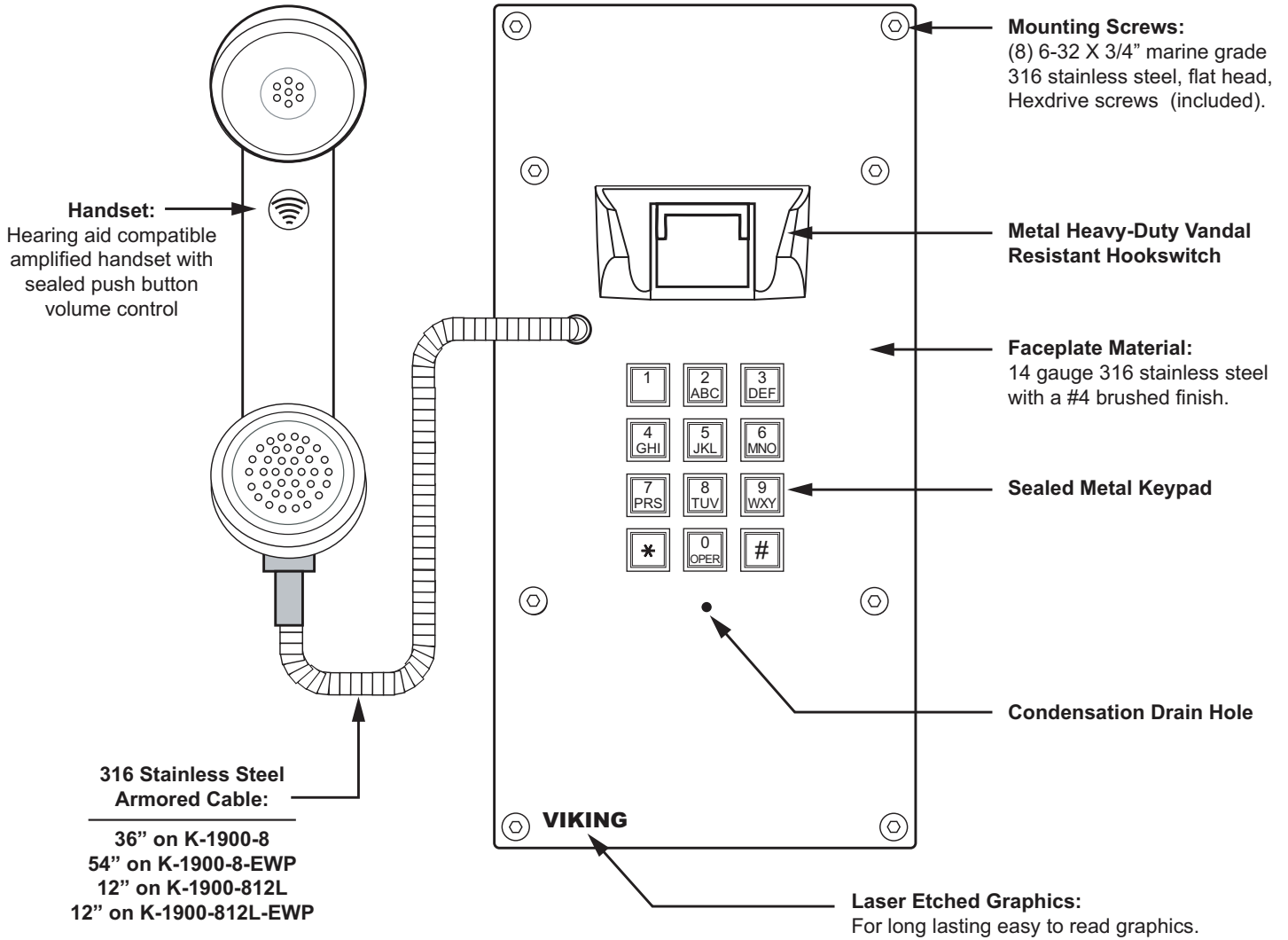

# Features Overview

## FRONT VIEW of the K-1900-8 Series Phone



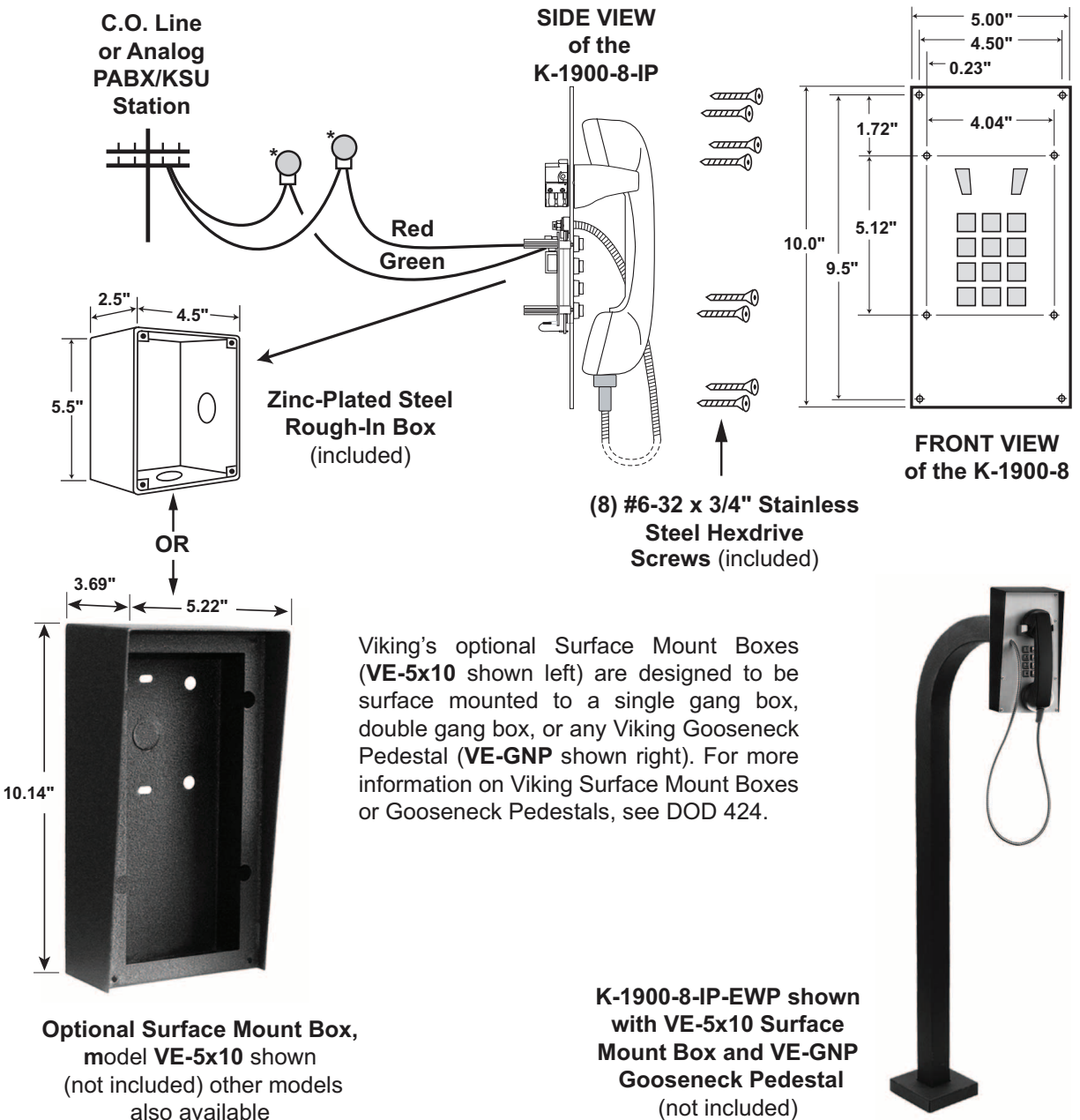
## Installation and Mounting

**⚠ IMPORTANT:** Electronic devices are susceptible to lightning and power station electrical surges from both the outlet and the telephone line. It is recommended that a surge protector be installed to protect against such surges.

To install the **K-1900-8** panel phone, attach the panel to an existing double gang box (with minimum dimensions shown below) using the provided screws or use the optional **VE-5x10** weather resistant surface mount box.

**Note:** Four extra screws and nuts are provided to fill the unused mounting holes. The optional **VE-5x10** surface mount box (shown below right) is designed to be surface mounted to a wall, post, single gang box or a **VE-GNP** or **VE-GNP-2** goose neck pedestal (shown below left). The **K-1900-8** can also be mounted in an optional **VE-9x20** Weatherproof Enclosure (**DOD 413**).

**Note:** When mounting a **K-1900-8-EWP** in a **VE-9x20**, the length of the handset cable must be reduced. Use a  $3/32$ " hex key or bit to loosen the set screw in the brass handset cable retainer. Pull approximately 18 inches of the cable through the panel and retighten the set screw.



\* **Note:** The gel-filled (water-tight) butt connectors are designed for insulating displacement on 19-26 gauge wire with a maximum insulation of 0.082 inches. Cut off stripped wire ends before terminating.

# Programming

## A. Security Code

A six digit number may be used to access the programming mode. The security code has been factory set to **845464** (V-I-K-I-N-G). It is recommended that you change the security code to a personal 6 digit number:

<b>Step 1</b>	Access programming as shown in section <b>B</b> .
<b>Step 2</b>	Enter your new security code followed by <b>#47</b> .
<b>Step 3</b>	To exit programming simply hang up the <b>K-1900-8</b> .

*Note: The security code must be six digits in length and **MUST NOT** contain a \* or #. If you have forgotten your security code, see section "B, 2. Accessing the Programming Mode Locally Without a Security Code."*

## B. Accessing the Programming Mode

### 1. Remote Programming Mode Locally with a Security Code

<b>Step 1</b>	Connect the green and red wires on the <b>K-1900-8</b> to a C.O. line or analog PABX/KSU station.
<b>Step 2</b>	From a Touch Tone phone, call the line connected to the <b>K-1900-8</b> .
<b>Step 3</b>	If using the multi-number dialer mode, set DIP switch 2 to <b>ON</b> .
<b>Step 4</b>	Take the <b>K-1900-8</b> off-hook (remove handset from the cradle). From the calling phone enter "*" followed by the six digit security code, factory set to <b>845464</b> (see section <b>A</b> above). A double beep will indicate that programming has been entered.
<b>Step 5</b>	Program as shown in sections <b>D - I</b> .
<b>Step 6</b>	To exit programming, hang up both phones.

### 2. Programming without Using the Security Code

<b>Step 1</b>	Connect the green and red wires on the <b>K-1900-8</b> to a C.O. line or analog PABX/KSU station.
<b>Step 2</b>	Set DIP switch 1 to <b>ON</b> .
<b>Step 3</b>	If using the multi-number dialer mode, set DIP switch 2 to <b>ON</b> .
<b>Step 4</b>	From a Touch Tone phone, call the line connected to the <b>K-1900-8</b> .
<b>Step 5</b>	Take the <b>K-1900-8</b> off-hook (remove handset from cradle). A double beep should be heard indicating you have entered programming.
<b>Step 6</b>	Program from calling phone as shown in sections <b>D - I</b> .
<b>Step 7</b>	Set DIP switch 1 back to <b>OFF</b> .
<b>Step 8</b>	To exit programming, simply hang-up the phones.

**Note:** Special features such as \*, #, a mode change and a pause, use single digits in the programming memory.

## D. Dialer Modes

The **K-1900-8** can operate in 3 different modes. With DIP switch 2 set to **OFF** and memory location **#00** cleared, the **K-1900-8** is in the Standard (Dumb) Phone mode. With DIP switch 2 set to **OFF** and a phone number programmed in memory location **#00**, the **K-1900-8** is in the Single Number Auto-Dialer mode. With DIP switch 2 set to **ON**, the **K-1900-8** becomes a Multi-Number Auto Dialer.

## E. Dialing Speed

To set the dialing speed, access the **Programming** mode as shown in section **B**, then choose a speed. To set the dialing speed to **Normal** (Touch Tone: 120ms on/off, Pulse: 10pps), enter **\*1**. To set the dialing speed to **Fast** (Touch Tone: 60ms on/off, Pulse: 20pps), enter **\*2**.

## F. Hand Held Pocket Dialers

The **K-1900-8** is programmed to hang-up if it detects Touch Tones it did not generate. This helps prevent toll fraud from hand held dialers. To set the **K-1900-8** to block/allow dialing from external devices, access the **Programming** mode as shown in section **B**, then choose block or allow. To **Block** hand held dialers, enter **\*3**. To **Allow** Touch Tones from external devices, enter **\*4**.

## G. Pre-Dial Pause

In the single number auto-dialer mode, the time from when the handset is taken off-hook until the **K-1900-8** auto-dials can be programmed. Access the **Programming** mode (section **B**), then choose a pause length. To set the pause length to **Normal** (approximately 1.4 seconds), enter **\*5**. To set the pause length to **Short** (approximately 800ms) enter **\*6**.

## H. Pauses in the Dialing String

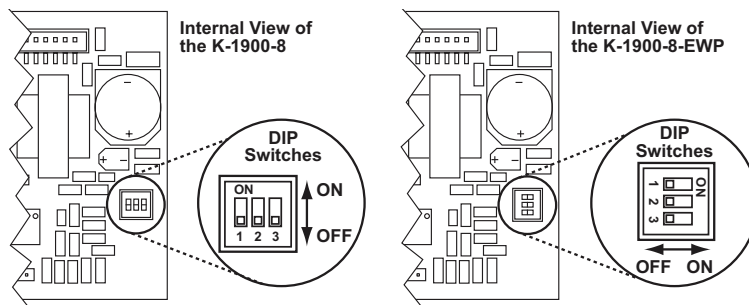
To set pauses in the dialing string, access the **Programming** mode as shown in section **B**, then enter **\*7** to put a 4 second pause anywhere in the dialing string, or **#7** for a 1 second pause.

## I. Toll restriction

When the **K-1900-8** is in the Standard (Dumb) phone mode, some limited toll restriction is available. With toll restriction enabled, the phone will hang-up if a 0 or 1 is entered as the first digit, or if more than ten digits are entered. Access the **Programming** mode (section **B**), then choose enable or disable toll restriction. To set the **K-1900-8** to **Disable** toll restriction, enter **\*9**. To set the **K-1900-8** to **Enable** toll restriction, enter **\*0**.

## J. DIP Switch Programming

Switch	Position	Description

*Note: DIP switch 3 is not used and should stay in the OFF position.*

# Operation

## A. Single Number Auto Dialer

In the single number auto dialer mode (see **Programming** section **D**), when the **K-1900-8** is taken off-hook it will speed dial the phone number programmed in memory location **#00**. After speed dialing is complete, the keypad is available for user Touch Tone signaling. In this mode, the **K-1900-8** can be programmed to block hand held dialers (see **Programming** section **F**).

## B. Standard (Dumb) Phone Mode

If nothing is programmed in memory locations **#00**, the **K-1900-8** drops into the dumb phone mode. The phone will act like any standard 2500 type telephone. The only feature which may be enabled is the limited toll restriction (see **Programming** section **I**).

## C. Multi-Number Auto Dialer

In the multi-number auto dialer mode (see **Programming** section **D**), when the **K-1900-8** is taken off-hook it will dial one of six speed dial numbers programmed in memory locations **#01**, **#02**, **#03**, **#04**, **#05** and **#00** when the user presses 1, 2, 3, 4, 5, or 0 (respectively) on the keypad. After speed dialing is complete, the keypad is available for user Touch Tone signaling. In this mode, the **K-1900-8** can be programmed to block hand held pocket dialers (see **Programming** section **F**).

## D. Handset Receiver Volume Adjustment

The **K-1900-8** has a sealed push button switch located on the inside handle of the handset. Each push of the button will rotate through the receiver volume levels if enabled. After four actuations, the receiver volume is back to its default setting. Hanging up the phone will automatically set the receiver volume to its default setting.

### Vandal Resistant VoIP Panel Phone with Auto Dialer and Relay Control

The **K-1900-7-IP Series** VoIP Panel Phones will auto-dial a 1-20 digit programmable phone number each time the handset is lifted. If the call is not answered, the phone will dial up to 3 additional phone numbers. The **K-1900-7-IP Series** phones are designed to provide quick and reliable communication for SIP VoIP phone systems with PoE. The unit can be programmed from any PC on the same LAN or remotely using a Static IP Address.

When a call initiated by the **K-1900-7-IP Series** phone is answered by an apartment or business tenant, a built-in relay may be activated to control an electric gate or door strike. The relay can also be programmed to activate whenever the phone is off hook, ideal for controlling cameras, etc.

The **K-1900-712L-IP** and **K-1900712LIPEWP** features a 12" long armored cable with internal stainless steel lanyard for additional cable strength.

The **K-1900-7-IP-EWP** and **K-1900712LIPEWP** share all the features of the standard **K-1900-7-IP** and **K-1900-712L-IP** in addition to Enhanced Weather Protection (EWP) for outdoor installations where the unit is exposed to precipitation or condensation. EWP products are designed to meet IP66 standards and may feature foam rubber gaskets, sealed connections, gel-filled butt connectors, as well as potted circuit boards with internally sealed, field-adjustable trim pots and DIP switches for easy on-site programming. ### Vandal Resistant VoIP Phone with Auto Dialer, Keypad and Entry System

The **K-1900-8-IP Series** panel phone can either auto-dial a phone number each time the handset is lifted, be used as a multi-number auto-dialer, or be used as a standard manual dial phone. The **K-1900-8-IP Series** phones are designed to provide quick and reliable communication for SIP VoIP phone systems with PoE. The unit can be programmed from any PC on the same LAN or remotely using a Static IP Address. The **K-1900-8-IP Series** phone can dial up to 250 programmable numbers and another 250 rollover numbers.

When a call initiated by the **K-1900-8-IP Series** phone is answered by an apartment or business tenant, a built-in contact closure may be activated to control an electric gate or door strike. Up to 1,000 keyless entry codes may be programmed, providing tenants with keyless entry. A 26 Bit Wiegand input is provided for adding an optional proximity card reader with capacity to program up to 1,000 card numbers. Keyless entry codes and card numbers can be programmed to only allow access at specific times and/or day of the week. A request for exit (REX) input is included for easy exiting. The **K-1900-8-IP Series** phone also has automatic event logging allowing you to review the time and date of the call, which door was open/closed, what keyless entry code or proximity card was used, request for exit usage and whether it was an inbound or outbound call.

# Warranty

## RETURNING PRODUCT FOR REPAIR

The following procedure is for equipment that needs repair:

1. Customer must contact Viking's Technical Support Department at 715-386-8666 to obtain a Return Authorization (RA) number. The customer MUST have a complete description of the problem, with all pertinent information regarding the defect, such as options set, conditions, symptoms, methods to duplicate problem, frequency of failure, etc.
2. Packing: Return equipment in original box or in proper packing so that damage will not occur while in transit. The original product boxes are not designed for shipping - an overpack box is required to prevent damage in transit. Static sensitive equipment such as a circuit board should be in an anti-static bag, sandwiched between foam and individually boxed. All equipment should be wrapped to avoid packing material lodging in or sticking to the equipment. Include ALL parts of the equipment. C.O.D. or freight collect shipments cannot be accepted. 3. Return shipping address: Be sure to include your return shipping address inside the box. We cannot ship to a PO Box.
4. RA number on carton: In large printing, write the RA number on the outside of each carton being returned.

## RETURNING PRODUCT FOR EXCHANGE

The following procedure is for equipment that has failed out-of-box (within 10 days of purchase):

1. Customer must contact Viking's Technical Support at 715-386-8666 to determine possible causes for the problem. The customer MUST be able to step through recommended tests for diagnosis.
2. If the Technical Support Product Specialist determines that the equipment is defective based on the customer's input and troubleshooting, a Return Authorization (RA) number will be issued. This number is valid for fourteen (14) calendar days from the date of issue.
3. After obtaining the RA number, return the approved equipment to your distributor. Please reference the RA number on the paperwork being shipped back with the unit(s), and also the outside of the shipping box. The original product boxes are not designed for shipping - an overpack box is required to prevent damage in transit. Once your distributor receives the package, they will replace the product over the counter at no charge. The distributor will then return the product to Viking using the same RA number.
4. **The distributor will NOT exchange this product without first obtaining the RA number from you. If you haven't followed the steps listed in 1, 2 and 3, be aware that you will have to pay a restocking charge.**

## TWO YEAR LIMITED WARRANTY

Viking warrants its products to be free from defects in the workmanship or materials, under normal use and service, for a period of two years from the date of purchase from any authorized Viking distributor. If at any time during the warranty period, the product is deemed defective or malfunctions, return the product to Viking Electronics, Inc., 1531 Industrial Street, Hudson, WI., 54016. Customer must contact Viking's Technical Support Department at 715-386-8666 to obtain a Return Authorization (R.A.) number.

This warranty does not cover any damage to the product due to lightning, over voltage, under voltage, accident, misuse, abuse, negligence or any damage caused by use of the product by the purchaser or others. This warranty does not cover non-EWP products that have been exposed to wet or corrosive environments. This warranty does not cover stainless steel surfaces that have not been properly maintained.
